



DFA's Direct Deposit beats the mail, every time!

Without lifting one little finger, thousands of DFA members now have their milk checks electronically wired directly into their bank accounts. No waiting for the mail carrier and rushing to the bank to beat the deposit cutoff.

Not only is Direct Deposit the surest way to get your money safely into your bank account, but it's the fastest. Members on direct deposit continue to receive, by mail, a printed copy of their milk checks including documentation of all transactions involved in their payment.

DFA deposits checks into member bank accounts within 24 hours, or the next business day, from the time checks normally would be mailed. That means no more worries about whether the mail will be on time or whether you will have time to go to the bank and deposit your check.

To participate in direct deposit, simply complete the form on the reverse side and mail it along with a voided check to your Area office. That will be the last time you have to depend on the mail service!

Convenience, reliability and efficiency are the reasons why more DFA members choose direct deposit over mail delivery. This technology saves you time and energy (this eliminates your trip to town), and is more economical for your cooperative.
